1	The total number of section of the school shall be restricted to 12 and further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft.
2	The library seen in the IC video is understocked and inadequate seating arrangement. Hence the school is directed to setup the library as per SoP issued by the board and submit the compliance within 3 months on SARAS portal.
3	The school has no ramp/lift for CWSN to access the upper floors. The school shall construct a ramp/install a lift as per norms of RPwD Act within 3 months and submit compliance on SARAS.
	The school has placed moveable wooden wedges outside CWSN toilets which are

4	not safe for students. Some CWSN toilets do not have enough space for navigation by CWSN. The school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, indicating the floor number/name as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
5	The school shall conduct training of its teachers with CoE Vijaywada within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

In this connection, I am directed to convey approval of the Board for shifting of school campus as per the details mentioned below on the basis of online documents and data uploaded by school.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

Sl. No.	The school is directed to ensure that :
1	The number of sections of Bal-Vatika shall be restricted to 6 (Two sections each in Bal Vatika I, II & III respectively) and total number of section of the school shall be restricted to 15 from class I to XII of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	Sexual harassment committee is being headed by a male member, as per norms of the Act the committee is to be headed by a senior women employee. School shall reconstitute Sexual harassment committee in the light of the provisions laid down in the Act within 03 months and submit the compliance.
3	Library is understocked and adequate seating to accommodate 50 students at a time is not available. ICT infrastructure is also not available in the library as mentioned in SoP. Separate reading area for staff is not developed by the school. School shall improve Library in the light of SoP issued by the Board within 03 months and submit the compliance.
4	Storage area, display of charts, Do's & Don'ts, periodical charts are not displayed. School shall upgrade the lab and also required add the Kits and models as mentioned in the SoP within 03 months and submit the compliance.
5	Biology Lab is understocked. Display of emergency contact details are not mentioned. Lab stools are not provided for seating in all science labs. Plastics chairs are not

	appropriate for seating. Safety features such as fire extinguisher are required to be installed in the labs. School shall setup all science labs in the light of SoP for labs issued by the Board within 03 months and submit the compliance.
6	The school shall ensure the mandatory training of its teachers with CoE, Vijayawada within 03 months and submit the compliance.
