In the 1st read above, Temporary Recognition was granted for classes I to VII EM for the academic years from 2021-2022 to 2023-2024 03 years in respect of DELHI PUBLIC SCHOOL, Nannur (V), Orvakal (M), Kurnool Dist.

In G.O. 2nd read above, the Govt. have extended the Recognition period from 03 academic years to 08 academic years in respect of Private unaided / aided schools

In the reference 5th read above, the Mandal Educational Officer, Orvakal (M) has submitted proposals and recommended to extend Temporary Recognition from 03 academic years i.e., from 2021-2022 to 2023-2024 to 08 academic years from 2021-2022 to 2028-2029 in respect of DELHI PUBLIC SCHOOL, Nannur (V), Orvakal (M), Kurnool Dist.

Therefore, after careful examination of the proposals and as per the instructions issued by the provisions contained vide G.O. 2nd read above and as per the instructions issued by the Commissioner of School Education, A.P., Amaravati vide reference 4th read above and under rule 3(i)(a) of G.O. Ms. No. 1 Edn Dept dated:01.01.1994 Temporary Recognition is hereby extended from 03 academic years i.e., from 2021-2022 to 2023-2024 to 08 academic years from 2021-2022 to 2028-2029 in respect of DELHI PUBLIC SCHOOL, Nannur (V), Orvakal (M), Kurnool Dist subject to fulfillment of the following conditions:

- 1. That the society shall abide by the instructions/rules and regulations made by the Government or authorized Officer from the time to time.
- 2. That the Educational Institutions shall serve the needs of the locality more particularly.
- 3. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 4. That the school timing vacations and mid term holidays shall be followed as prescribed by Government from time to time.
- 5. That the qualified staff within the age limits prescribed by Government employees shall be appointed with the management own funds as per staff pattern.
- 6. That the results of institution shall be satisfactory every year.
- 7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
- 11. That the school shall not be remained closed without giving notice both to the parents / District Educational Officer, and competent authority at least six months before.
- 12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 13. That the society shall apply for recognition by 31.08.2023 at the latest duly fulfilling the conditions.

- 14. That the society shall provide fire safety measures in the school as per the No objection certificate / advise of the Fire Services Department authorities.
- 15. The management is informed that no thatched roof accommodation is allowed to run the school.
- 16. Proper and adequate sanitation facility shall be provided for students especially for girl students.
- 17. The school shall follow the traffic and safety measures shall be taken for children within the school campus and also near the school premises.
- 18. The school shall follow the traffic and safety guidelines indicated by the police and fire services, Departments.
- 19. The parent teachers associations meeting should be conducted to sensitize the parents on the safety of the children and also for the various health concerns of their children.
- 20. The school shall have first aid kit and the teachers shall be trained in first aid.
- 21. The Correspondent of the concerned school is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time without fail.
- 22. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
- 23. That the management shall take every responsibility for the timely, safe and comfortable mobility of the School Children from the residences to School and vice versa.
- 24. That the School Van if any should be ensured road worthy for the transportation mobility of school children.
- 25. That the school van should be free from all taxes due and should be maintained with regular checks by authorized mechanics periodically / as and when required without causing any sort of dislocation for the school children opting the van facility.
- 26. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the school vans if any.
- 27. That the management shall insure the vehicle and safety grills be provided to all the windows of the vehicles if any without fail.
- 28. That management shall ensure the accounts of the school audited by an authorized chartered accountant every year and submit.
- 29. The management shall have to follow the rules and guidelines issued to Go.Ms.No.91, Edn., Dt.06.08.2009 regarding fee structure in private Schools.
- 30. The management shall have to follow the G.O Ms.No.01 and subsequent G.Os / memos issued from time to time without any deviation.
- 31. That the management shall not run any Pre-primary classes other than those now permitted and also shall not run hostel
- 32. That the management shall ensure all the children studying in their school shall be brought in to child info without fail.
- 33. That the Management shall maintain / provide required fire extinguishers in the school premises immediately.
- 34. That the Management shall ensured for the regular health check up of the school children periodically and shall coordinate with the Medical & Health Department authorities concerned without fail.
- 35. The inspecting officer shall ensure that all the conditions are fulfilled and shall submit compliance report in two (02) months.
- 36. Any deviation of the norms / guidelines issued from time to time will be viewed seriously.
